

Hasil Pertemuan Monitoring dan Evaluasi
Pelaksanaan Kesepakatan Pt. ANI dan Sajingan Kecil
Pontianak, 17 Juni 2011.

1. Peran Tim Monev adalah memastikan apa yang wajib dipenuhi oleh para penyepakat yang terlibat di dalam kesepakatan induk, telah dilaksanakan.
2. Sehubungan dengan telah ditanamnya plasma 10,2 hektar, diasumsikan bahwa semua areal plasma 472 ha sudah ditanam. Untuk itu Tim Monev akan melakukan kunjungan MONEV lapangan dilaksanakan sebelum masuk bulan puasa. Masyarakat Sajingan Kecil akan membuat daftar spot yang akan dimonev, dan Pt ANI terbuka untuk itu.
3. Sehubungan dengan reforestasi 47 ha, dan informasi yang didapat bahwa lahan tersebut adalah lahan APL, maka ada 4 opsi pemanfaatan lahan yang berkembang selama pertemuan:
 - a. Tetap dilakukan reforestasi sesuai kesepakatan induk.
 - b. Ditanam karet.
 - c. Ditanam sawit.
 - d. Kompensasi tanam sesuai dengan surat Sajingan Kecil tanggal 18 April 2011.
Dari keempat opsi tersebut, masyarakat mengusulkan kompensasi tanam. Pt ANI akan memberi jawaban pada awal bulan Juli 2011








Results of Monitoring and Evaluation Meeting on The
Implementation of Agreement Pt. ANI – Sajingan Kecil.
Pontianak, June 17, 2011.

1. Role of Monitoring and Evaluation Team is to ensure sure what that must be met by the penyepakat involved in the parent agreement.
2. In connection with finalizing the planting of 10.2 hectares in the smallholder plantation area, it is assumed that all smallholder area of 472 ha have been planted. For that M & E Team will conduct field visits undertaken before entering the month of fasting. Sajingan Kecil community representative will make a list of spots that will be visited for evaluation, and Pt ANI welcomes to it.
3. In connection with the reforestation of 47 ha, and the information that the land is APL Area, then there are four land-use options discoursing during the meeting:
 - a. Reforestation must be done according to the parent agreement.
 - b. Planted with rubber.
 - c. Planted with palm.
 - d. Planting Compensation as proposed Sajingan Kecil in the letter dated 18 April 2011.
Of the four options, community proposed planting compensation. Pt ANI will provide an answer at the beginning of July 2011.
